# SOLICITOR'S REPORT October 8, 2019

To the Board of Directors,

The litigation in the Best Home, LLC vs. The Stormwater Authority of the City of Chester is finally concluded. Closing briefs were submitted to the Court last week. Mr. Oxman personally thanked the Board and Executive Office of the Authority for their patience in this matter. The suit was brought against the Authority in January 2018 and have taken almost two years to conclude. Mr. Oxman stated that he feels more than confident that the Authority will prevail.

Tom Musci, counsel for the Plaintiffs, Best Homes, again in two different trials before Judge Angelos and Judge Whelan, the Plaintiffs were unable to proffer any factual or expert derived testimony that the Authority was formed with malfeasants, that Delcora is really the Stormwater Authority, and that the Authority's fee structure was arbitrary and calculated without accepted engineering methodologies. In fact, Plaintiffs attempted to make their entire case by relentlessly cross-examining Dr. Strand without establishing any rebuttal evidence whatsoever. Plaintiffs case was always an outright sham

As soon as we get a ruling from the Court, a collection firm, Portnoff Associates, will be mailing out initial notices of default and lack of payment for fees to all outstanding bill holders, commercial and residential.

# EXECUTIVE MANAGER'S REPORT October 8, 2019

In August, we submitted a \$9,000,000 plan to PENNVEST, and are waiting for their response. If successful, we will receive funds to purchase needful equipment. We also hope that most of the funds will be given to us as a grant. The plan submitted calls for a purchase of a state-of-the-art street sweeper and a vacuum truck to clean inlets. We should hear from them in October.

We needed to repair sidewalks on 410 Welsh Street. The work has been completed and we are waiting final City inspection. The work on 29 East 5<sup>th</sup> Street is completed and is waiting for final inspection and a Certificate of Occupancy from the City.

The men are doing a great job keeping inlets clean and responding to many calls we get from rate payers throughout the City. We are working on plans to move into our new headquarters and have our ribbon cutting ceremony. A good portion of our times has been working to ensure that our Contractor is working well, and that all Chester residents are taken care of in every matter. Overall, things are going well, and we look forward to the future.
